INTRODUCTION

The Herman T. Pott National Inland Waterways Library

The Herman T. Pott National Inland Waterways Library was established in 1985 with major funding from the Herman T. and Phenie R. Pott Foundation, a foundation with special interests in education and the preservation of river heritage. The Pott Library is an important national resource for scholars, river aficionados, and students of America's rivers because of its unique and extensive literary, archival and photographic collections of inland waterways materials.

Archival materials in the Pott Library do not circulate, but may be used by researchers at the library during reading room hours. Researchers may arrange for copies of documents and photographs from the curator of the Pott Library for a fee, according to the St. Louis Mercantile Library's Image and Price List.

HISTORICAL NOTE

The National Waterways Conference was established in 1960 and is an advocate for practical water resource policies. The Conference also recognizes the public value of America's water sources. Membership includes flood control associations, levee boards, waterway shippers, port authorities and shipyards, among others.

The headquarters of the Conference are located at 4650 Washington Blvd., #608, Arlington, Virginia 22201. There is an annual meeting and the Conference is directed by a board consisting of 45 directors, each a designated representative of a marine corporation. In addition to the annual meeting, the National Waterways Conference takes part in regional meetings of similarly minded groups such as the Gulf Intracoastal Canal Association and the American Association of Port Authorities in Seattle, Washington.

In the interest of advancing its goals and of educating the public, the Conference participates in a large number of public outreach programs to encourage support and understanding of American waterways.
